MIXING INSTRUCTIONS

Shake the container well before each use. For optimum performance, water pH should be between 5 and 8. Partially fill the spray tank with water, add the required amounts of CRYPTOMAX™ and adjuvants while agitating and top up the spray tank with water to the required volume.

APPLICATION INSTRUCTIONS

CRYPTOMAX™ should be applied immediately after mixing. Under no circumstances should it be left to stand overnight. CRYPTOMAX™ must be applied with an oscillating tower mist blower or with handheld spray guns. CRYPTOMAX™ must be applied as a full cover film spray. Do not concentrate the mixture in mist blowers. Due to the UV sensitivity of CRYPTOMAX™, it must not be applied during the heat of the day. Sprays must be applied during the late afternoon or at night.

RECOMMENDATIONS

False Codling Moth	Citrus	10ml + wetter*	Apply as a full cover film spray from when the pest first occurs. Sprays should be applied shortly after moth flight peaks.
			A final application 4 weeks before harvest is recommended. Apply during later afternoon or evening.
			In high pest pressure conditions, the application of molasses at 250ml per 100L water is recom- mended.

*Non-ionic organo-silicone or alkylated phenol-ethylene oxide wetters recommended at the registered rate such as, L6764 Break-Thru™, Polyether-polymethylsiloxane -copolymer, Evonik
