## DIRECTIONS FOR USE: USE ONLY AS DIRECTED. GENERAL INSTRUCTIONS

MYTECH\* WP contains spores of Paecilomyces lilacinus a nematophagous fungus that is used for control of CERTAIN soil borne plant parasitic nematodes including Meloidogyne spp. MYTECH\* WP may be incorporated into growing medium or applied directly into the soil through drip lines, as a drench application or as a basal spray using spray equipment. Thorough irrigation is recommended. Owing to its mode of action as a non-curative treatment, MYTECH® WP should be applied preventively before nematodes gain access into the plant roots.

Do not apply MYTECH\* WP if the nematode pest pressure is unknown as the product is not suitable for use in high nematode pressure situations and may require additional control measures and use as part of an integrated programme to achieve satisfactory control of the target pest. Consult production guidelines for nematode crop thresholds. If nematode count is high, a preplant chemical nematicide/fumigant is recommended. MYTECH\* WP is not suitable for use in seed potatoes.

COMPATABILITY: MYTECH\* WP is incompatible with certain chemicals including triazoles, benomyl and imazalil. DO NOT TANK MIX WITH ANY FUNGICIDES. Contact RIVER BIOSCIENCE (PTY) LTD for more information.

APPLICATION INSTRUCTIONS: Add the required amount of MYTECH® WP with water using 1 litre for every 125g product; stir well to form a uniform suspension. Add the suspension to the required volume of water in the spray tank and mix well. Add an appropriate wetter at recommended rates and mix thoroughly. After mixing with water the product should be drenched/Band applied as soon as possible and washed in with more volumes of water; DO NOT store overnight.

Recommendations: Use MYTECH® WP in an integrated programme for the management of plant parasitic nematodes. Ensure application is done in a minimum volume of 1 000L water per hectare followed by 1 000 - 1 500L water to ensure penetration into the root zone. First application should be undertaken 10-14 days prior to planting. Repeat application 4 weeks after planting, and every 4 weeks thereafter whilst the crop is susceptible to nematode damage.
